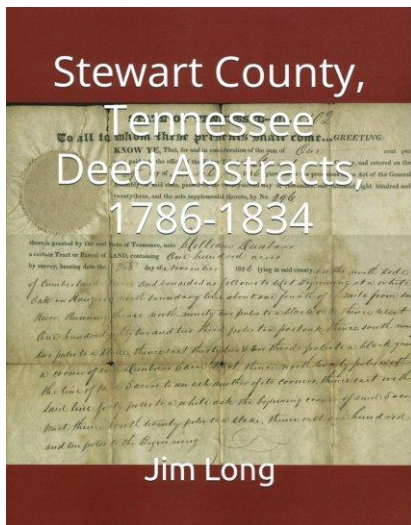

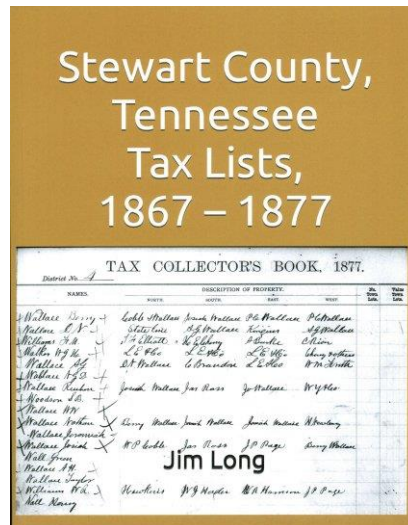

Description: This publication contains abstracts of Stewart County, Tennessee land records covering the years 1786 through 1834. It abstracts the first 10 Stewart County deed books (1804-1834), as well as the North Carolina land grants in the county (1786-1803) that preceded county formation. Included are many grants for land in present-day West Tennessee that were registered in Stewart County before West Tennessee had any counties.

Additionally, the book includes abstracts of hundreds of Tennessee and Kentucky state land grants for land in the county that were never recorded in the county's deed books, but only in the state Land Grant Books.

About the Compiler: Jim Long has been doing genealogical work in Stewart County records for over 40 years. He is a volunteer at the Stewart County Archives, is the County Coordinator of the TNGenWeb Stewart County Genealogy web site (<http://www.tngenweb.org/stewart/>), and is a Board Member of the Middle Tennessee Genealogical Society. He has previously published eighteen books of genealogical research material on Stewart County.

Description: These publications transcribe the surviving Stewart County, Tennessee tax records from 1867-1888.

There is some loss of the original tax lists during this period, but these losses have been overcome by the survival of delinquent tax lists, lists of tax exonerations, and lists of lands sold for delinquent taxes. Tax records are remarkably intact for the county.

Tax records are a great alternative to census and other traditional genealogical records, as they can add detail to a person's timeline every year, instead of every 10 years.
