SCOPE AND CONTENT NOTE

In 2020, the Mary Ann Scurlock Collection was donated by her family, with additional items loaned for digitization only.

Mary Ann (Bruton) Scurlock (1927-2020) was the daughter of Harvey and Lora Seay Brandon Bruton. She founded Mary Ann's Flower Shop in Dover and was a member of the Ft. Donelson Memorial United Methodist Church. She was the widow of James T. Scurlock.

The collection includes several 1930s issues of the Stewart County Times newspaper, various family and Dover photographs, and an interesting compilation of Civil War research material. A 48-star U. S. Flag is also in the collection.
